St. Paul Lutheran Council Meeting Minutes



October 16, 2016

<u>Present:</u> Deb Elliott, Jim Reider, Jim Whitten, Dave Schlaack, Peg Booher, Steve Mishler, Pastor Turanski

Absent: George White, Peg Walters,

<u>Call to order by</u> President Deb Elliott at 11:30 am in church basement.

Opening Prayer: Pastor Turanski

Congregational Comment: None

Approval of Agenda: Jim Whitten asked that the Commissioned Lay Leader appointments be added to Old Business.

Secretary's Report:

No meeting was held in September due to lack of quorum. Dave Schlaack motion to accept August 28 meeting minutes. — carried.

Treasurer's Report:

August Income: 4,965.00, Expenses \$6,966.97, Variance -2001.97

September Income: \$3,189, Expenses \$4,793.93. Variance, -\$1,604.93

Sept. 30 Ckg Bal: \$27,396.46, Spec. Acct Bal. \$5,466.27

Peg Booher advised that September Special Offering received for LSSM was \$10. Benevolence added additional \$90.

Motion to accept Treasurer's report by Steve Mishler, carried.

<u>Pastor & Elders</u> –Submitted in writing.

Tuesday evening study, "Odyssey of St. Paul", will continue each week until end of November.

NALC Michigan Mission District will meet here on Tuesday, Oct 19.

Pastor advised he will again be taking off the month of January. Terese Whitten will be preaching and leading services. Pastor suggested compensating her for filling in while he is away.

<u>Worship and Music</u> – Submitted in writing and verbally.

Jim Whitten reported that we are continuing the Folk Mass liturgy until

Advent. A new gathering song will be incorporated into the current music beginning on Oct. 30. Ideas for Advent mid-week services are being considered. Terese Whitten has resigned from the committee and a new chairman has not yet been determined.

Property: - Submitted verbally.

Dave Schlaack reported that re-grading around the front & side of church has been completed. We hope to re-seed the lawn this fall. Gutters will be installed along roof eaves in critical areas between the fellowship hall and the sanctuary. Dave will get cost estimates to resurface/paint the parking lots.

<u>Community Dinner</u> – Report deferred to Old Business.

Call Committee: No report.

Jim Whitten reported that NALC has developed a workshop to help congregations work through the Call process. This information will be passed on to our Call Committee.

Motion to accept Reports, carried.

Old Business:

Community Dinner - Deb Elliott reported that the committee has set up an independent checking account. Jim Whitten noted that the original Council resolution that created this committee clearly called for all funds received and spent be handled by the St. Paul Treasurer. A copy of the original resolution will be given to members of council. Deb is planning to meet with the committee to

discuss the possible need for getting nonprofit status to operate as a separate entity from St. Paul and how funds are to be handled until that time.

<u>Urns for memorial bench</u>. - Urns for outside bench have been received. The urn bases will be changed before planting is made.

Commissioned Lay Leaders

The following proposal was approved at the August 28, 2016 council meeting to be voted on by the congregation, at the next annual meeting: Shall Terese Whitten and Ruth Mowat be appointed as Commissioned Lay Leaders at St. Paul to perform the following duties: 1) Preach from the pulpit of St. Paul when authorized by the Pastor. 2) Lead worship at St. Paul, including the distribution of pre-consecrated elements, when authorized by the Pastor. 3) Perform other Pastoral duties if authorized by the Pastor. 4) Commissioned Lay Leaders would be expected to be reasonably available to make emergency Pastoral visits in the absence of the Pastor if requested by congregation members. 5) Compensation for these duties would follow guidelines established for Supply Clergy when leading an authorized St. Paul service. If approved by the congregation, this appointment would officially authorize duties that Terese and Ruth are already performing. Jim Whitten reported that he had talked with Ruth and Terese about the possible appointment. He will present them with the list of duties which will be published in these minutes.

Further discussion of the topic of compensation was held. A motion by Dave Schlaack, 2nd by Steve Mishler to

authorize compensation to Commissioned Lay Leaders for conducting services, when authorized by the Pastor, at the current level of \$150 per Sunday service plus mileage. Motion passed unanimously.

New Business:

Annual Meeting & Installation. Council agreed that our Annual Meeting will be scheduled for Sunday, December 11, 2016. Installation of Council, Elders, and Commissioned Lay Leaders will be held on Sunday, December 18, 2016, before Pastor Turanski leaves for vacation in January. Terese Whitten will be asked to prepare the congregation Voters List and present it to Council at the November meeting.

Need for new Council members.

Discussion of who is going off council and their possible replacements. Steve Mishler, Dave Schlaack & George White's 3-year terms will end in December. Peg Booher was appointed to serve only this year until December. Potentially 4 members of Council can be elected at the annual meeting. Jim Whitten's term ends in Dec. 2017. Deb Elliott, Jimmie Reider & Peg Walters terms end in Dec. 2018. Deb Elliott urged those eligible, whose terms are ending, to consider standing for reelection. Also, to talk with others who we feel may be ready to serve on Council.

Appreciation for Rick Machleit. Motion by Jimmie Reider to give gift cards totaling \$100 to Rick for his work on the church building and grounds. 2nd by Steve Mishler. Motion passed. A card will be

available at the 10/23 service for members to sign.

Gas Meter Cover. Peg Booher reports that DTE does not provide covers for their gas meters. They suggesting purchasing a cover from stores such as Lowe's or Menards. No action taken.

Correspondence:

Several requests have been received for donation. They were passed to the Benevolence Committee.

It was noted that contributions to our monthly special offering recipients has dwindled this fall.

A motion by Steve Mishler, 2nd by Jimmie Reider, to send \$200 to Water Mission, in response to a request from NALC for financial help. Motion passed.

Suggestion Box: No suggestions.

Meeting closed with the Lord's Prayer.
